Dear Resident or Property Owner:

In October a petition was received from a resident on your street asking the City to consider restricting on-street parking along the west side of 18<sup>th</sup> Avenue between Park Road and E 89<sup>th</sup> Street and allow parking on the east side of 18<sup>th</sup> Avenue between Park Road and E 89<sup>th</sup> Street. Based on the petition received and Staff evaluation of the area the following parking modifications are being proposed:

**Allow parking on the east side of 18<sup>th</sup> Avenue between Park Road and E 89<sup>th</sup> Street; “No Parking, This Block” on the west side of 18<sup>th</sup> Avenue between Park Road and E 89<sup>th</sup> Street**

If this change is approved, parking on the east side of 18<sup>th</sup> Avenue would be allowed at any time, for up to 24 consecutive hours while parking on the west side would be prohibited. Please provide comments regarding the proposed changes on the attached survey and return it in the enclosed, postage paid envelope. Please include your name and address on the bottom of the survey and return it by December 5, 2014.

Following review of the returned surveys, a final plan will be developed and you will be notified of the decision prior to implementation of any sign/parking modifications in the area. Please feel free to contact me with any questions.
